



AREA F 16U AND 19U
INTRA-AREA PROGRAM
RULES
2019-2020

1-SCOPE

These rules shall apply to 16U and 19U teams playing in the Area F fall program and to any secondary season 16U and 19U teams comprised of players who played in the Area F fall program. These rules do not supersede AYSO Rules and Regulations, but are intended to cover those situations not addressed by AYSO Rules and Regulations, which shall prevail in case of conflict. The following rules are designed to achieve the highest degree of sportsmanship in keeping with the AYSO philosophy, and to give all players, coaches and spectators the opportunity to participate in a wholesome environment.

2-JURISDICTION

The Area Director (herein referred to as AD) during the Area F fall program shall have sole jurisdiction over all team's subject to the provisions of these rules, in any disciplinary decision made pursuant to these rules and in the enforcement, recommendations made by any Due Process Review established under the provisions of paragraph 26.7 of these rules. During the secondary season, the Regional Commissioner (herein referred to as RC) shall have sole jurisdiction over their Region's teams subject to the provisions of these rules, in any disciplinary decision made pursuant to these rules and in the enforcement, recommendations made by any Due Process Review established under the provisions of paragraph 26.7 of these rules. The RC has the option to request that the AD and Area take the lead on situations where it is in the best interest of all parties involved.

3-COORDINATION

Intra-Area play shall be coordinated by the AD or his designee who has sole responsibility for running the Division 16U and 19U programs.

4-TEAMS AND PLAYER ELIGIBILITY

- 4.1 Each RC is responsible for ensuring the eligibility of the players from his/her Region. The RCs signature on the AYSO roster confirms the eligibility of each player. A player may ONLY move up one age/year in eligibility.

4.2 All players must have played in at least one-half of the games with the respective team during the AYSO Fall 2019 season to qualify for the Section Playoffs and/or post season playoffs and the Select/Tournament season. The ONLY exception is if an injury or illness prevented them from playing the minimum number of games.

5-COACHES

Coaches participating in the Area F fall program, Section playoffs and /or post season Select/Tournaments must have previously completed a Safe Haven Coach or AYSO's Safe Haven course, taken AYSO CDC Concussion Awareness training and be age specific Advance Coach trained.

6-CONDUCT

6.1 The RC shall be held responsible for the conduct of his/her coaches who in turn shall be responsible for the conduct of their players and spectators. **PERSISTENT INTERFERENCE WITH THE GAME FROM THE SIDELINES MAY BE CAUSE FOR TERMINATION OF THE GAME AND/OR THE SUSPENSION OF PLAYERS, COACHES OR SPECTATORS FROM FUTURE GAMES.**

6.2 The privilege of participating in Section 1 Playoffs is not automatic, but by invitation. The AD will advance teams which demonstrate the highest level of sportsmanship and character. The AD views the definition of a team as players, coaches and spectators.

7-TEAM FORMATION

Each RC is responsible for overseeing a selection method that will achieve the highest degree possible in the formation of BALANCED TEAMS from his\her region. When balancing teams, the player pool will be divided up by player ages to ensure that each team has a similar number of players from each age group and then the teams must be balanced by using player ratings within each age group. Each Region is required to have a draft if there is more than 1 team. The draft must be run by a disinterested party (someone that is not a coach in that division nor has a child playing in that division). Teams will not be approved until the AD has verified that the Region has taken the appropriate steps to balance the teams as stated above, proof of verification may be requested. The AD may request to be present at a draft, if this request is made, the AD must be allowed to witness the draft process. The maximum number of players on a team shall be 18; however, with the approval of the AD that number may be increased to 22 or decreased if small-sided games will be played. All teams shall have a minimum of 16 players on their roster unless approved by the AD or their designee. For short-sided games, teams will be 9v9 with a maximum roster of 14 players. Teams must have a minimum of 7 players in order to play otherwise the game will result in a forfeit. Once the draft process is completed and team approved by the AD, no other teams for that Region, in that division/gender will be accepted without the AD's approval.

8-AYSO TEAM ROSTER

The RC is responsible for providing the AD or their designee with the number of teams by division which will participate in the Area F upper division fall program by no later than September 1st. Regions who fail to uphold this date may be omitted from the schedule. Fully completed AYSO rosters must include player jersey number and BIRTH DATE, and must be given to the AD no later than 24 hours before the first game for verification. Any wrong information in the AYSO roster will result in game forfeiture and further disciplinary action. The AD shall have final authority in approving Intra-Area teams.

9-AYSO ROSTER CHANGES

Any changes to the final team AYSO roster must have the approval of the AD. Any additional players must be approved prior to his\her participation in a game and must be submitted by the RC to the AD or his/her designee. No player may be added to a team after completion of one-half of the season's scheduled games. Any team that plays a game with an ineligible player may be subjected to a forfeiture of all previous games as decided by the AD.

10-HOME TEAM

The designated home team is the first team listed on the schedule for each game and the home team is on the north or west side of the field. The home team is responsible for supplying the game ball and shall change jerseys in the event of a color conflict.

11-TEAM FIELD DUTIES AND ETIQUETTE

Both first game teams listed on the schedule for Wednesday, Saturday and Sunday are responsible to mark the fields before the games can begin. All first-game teams listed on the schedule for Wednesday, Saturday and Sunday are responsible for set-up of the equipment (goals, nets, flags) from the designated locations. Both last-game teams listed on the schedule are responsible for the takedown of the fields, cleanup and pickup of the entire playing area, and returning the field equipment to the designated locations. Each team is responsible for bringing their own trash bags, picking up their own trash and depositing their trash bags in dumpsters located at the site or taking it home. Failure to leave the fields and grounds clean may result in the loss of the use of the fields to the Area and cancellation of the remainder of the season. Each parent and visitor is responsible for the activities of their children in the playing area.

Any vandalism to the playing area or to residential areas immediately around the playing area could result in the loss of the fields to the Area and cancellation of the remainder of the season. No dogs, smoking, vapes, e-cigs, artificial noisemakers, drones or any flying apparatus are allowed anywhere insight or in hearing distance of the playing area.

12-GAMES

12.1 Regular Division Games

If playing regular division games, they shall be played as scheduled within the following divisions, 16U, two 40-minute halves and 19U, two 45-minute halves. Failure to play a game as scheduled or refusing to continue to play a game that has already begun when so directed by the referee, shall be subject to disciplinary action including exclusion of participation in postseason or tournament play. Purposely starting a game with less than 11 players in the presence of substitutions in order to allow a particular late player entrance into the game upon their arrival is not in keeping with AYSO soccer philosophy **AND WILL NOT BE ALLOWED. THE GAME WILL START WHEN THE MINIMUM NUMBER OF PLAYERS ARE PRESENT.**

12.2 Short Sided Games

If playing short sided games, they shall be played as scheduled within the following division, 16U, two 30-minute halves, and 19U, two 30-minute halves. Failure to play a game as scheduled or refusing to continue to play a game that has already begun when so directed by the referee, shall be subject to disciplinary action including exclusion of participation in postseason or tournament play. Purposely starting a game with less than 9 players in the presence of substitutions in order to allow a particular late player entrance into the game upon their arrival is not in keeping with AYSO soccer philosophy **AND WILL NOT BE ALLOWED. THE GAME WILL START WHEN THE MINIMUM NUMBER OF PLAYERS ARE PRESENT.** In addition, any player receiving a yellow card will have to sit for a cooling off period of at least 3 minutes after issuance of the card. A substitution can be made for this player. **Offside will not be called during the game.**

12.3 Schedules will not be changed once sent out except in case of field availability or conditions. **ALL TEAMS MUST PLAY ALL THEIR SCHEDULED GAMES.**

12.4 Playoffs

For the Playoffs, we will have single elimination playoff bracket. All matches ending in a tie will have two full overtime periods of five minutes in length with teams changing field direction after the first five-minute period. In these matches, if still tied after overtime play, the game shall be decided by FIFA kicks from the penalty mark. If a winner has not been determined after going through the full team, a coin flip will determine the winner.

Divisions playing short-sided games will not be playing in the Section Playoffs. Section Playoffs only allow full teams to advance.

13-GRACE PERIOD

The referee shall allow a grace period of ten (10) minutes. This grace period will start at the scheduled kickoff time for the game. If one or both teams are not ready to play after the grace period has ended, the referee or AD may cancel the game.

14-ALL GAMES ARE FINAL – There will be no changes made to the final outcome of a game. Game cards and referee reports are always reviewed by AD. If any you have any concerns on a specific game, email the AD at the address listed at the end of this document requesting a more in-depth review. The outcome will not change, however, if deemed necessary, additional training might be necessary. The AD will not make any disciplinary action public.

15-CANCELLED GAMES

Only the referee, the AD or his/her designee may cancel a scheduled game. Games cancelled due to dangerous field conditions or weather may be replayed in their entirety if the outcome would affect the final standings. The outcome of games terminated by the referee due to control problems or refusal of a team to continue to play when so directed by the referee will be determined by a hearing of a Due Process Board convened by the AD as set forth in paragraph 26.7 of these rules.

16-GAME CARDS

Coaches are responsible for submitting fully completed game line-up cards to the referee at least 10 minutes prior to kick off. The players shall be listed **NUMERICALLY**. The referee is responsible for completing the front and back of the card (evaluation of the game, players and spectators). The coaches are to turn in a Team Monitoring Form for substitutions to the referee. Both the Team Monitoring Forms and game cards need to be placed in either game card box at Columbia. One is located on the fence that encases one of the anchors for the radio antenna near the Upper Division Fields or the one on the fence that encases another anchor for the radio antenna near the snack shack. Coaches are to take a picture of the front and back of the game cards as well as the Time Monitor forms and email them to the Area Director at A1FADJEZ@gmail.com after each game.

17-MEDICAL RELEASES

Coaches shall not allow players to practice or play without a hardcopy of the Medical/Player Release Forms in their possession at all practices and games. If a player is caught practicing/playing without a Medical/Player Release Form present, the coach will be suspended for one game. Multiple infractions could possibly result in suspension for rest of the season.

18-EQUIPMENT

Player's equipment shall conform to AYSO Uniform National Specifications and the following:

1. Shin guards are required to be worn at all practices and games. They shall be covered entirely by the stockings, shall be commercially manufactured, and shall be of such a size to afford adequate protection to the player.
2. Bicycle shorts are allowed as an addition to the uniform if they are the same color as the uniform shorts.
3. Uniform jerseys shall have sleeves (no tank tops allowed).

4. A player may wear headgear only as a reflection of their religious practices and of a type approved by AYSO National Office.
5. A player may wear no jewelry of any kind.
6. Players with casts or splints are not allowed to practice or participate in any games.
7. Players must continue to wear their uniforms, including jerseys, until they leave the parking area. A player who removes his jersey when celebrating a goal will be cautioned for unsporting behavior.
8. All player uniforms must have a traditional AYSO logo.
9. It is highly recommended that the goal keeper's jersey has the traditional AYSO logo. In addition, no other writing shall be found on the goal keeper jersey except the manufacturer's logo.
10. If a Region has a variance filed with the AYSO National Office, the document must be presented by the RC to the AD in order for the variance to be allowed.

Players may wear hard knee braces if they meet the following requirements:

1. Provide a signed letter from their doctor to the AD, which states that the player is required to wear a knee brace while playing soccer.
2. Provide a signed letter from their parents to the AD, which states that they are aware of their child's injury, that their child's doctor has orders their child to wear a brace while playing soccer, and under these circumstances, give their permission for their child to play soccer.
3. Prior to the start of the game, players wearing braces must receive an approval from the AD or his designee that the brace and its fasteners are adequately covered and padded. Approval will be noted on the game card.
4. The referee shall be responsible for ensuring that the brace continued to be safe during the game. If the brace should become unsafe by accident or due to the player's action, the player shall be removed from the game, can be substituted for and will not be allowed to reenter the game.

19-REFEREE/REFEREE REPORTS

Referees will be assigned by the Area Referee Administrator or their designee with the help of the Regional Referee Administrators or Regional Referee Coordinators. Referees shall submit a detailed report within 24 hours to the ARA and AD on all red cards (send offs, dismissals) for serious foul play or violent conduct and any abusive conduct on the part of the players, coaches or spectators. See paragraph 26.7 for additional information. If a coach or spectator needs to receive a warning or dismissal, the referee will address the coach or their assistant only, not the spectator. The referee will document the concern on the game card and if appropriate, fill out a misconduct report.

20-SUBSTITUTION

Open Substitution is permitted in 16U and 19U. Every player must play at least one half of every game unless injured or ill. A Time Monitoring Form must be filled out and turned in to the Referees at the end of the match. If a Time Monitoring Form is not turned in for a team, the game will be marked as a forfeit for the one that didn't turn it in. There will be no grace period. It is the coach's responsibility to get the form to the referees

shortly after the game finishes. No late forms will be accepted. If a coach has been found to intentionally not play players for at least half the game, they will be suspended for 2 games. All forms and game cards will be reviewed by the AD. If the coach continues to violate this policy, he/she will be suspended for the rest of the season and possible not be accepted as a coach the following year.

21-INJURIES/BLEEDING

Any injury that occurs during a game involving any AYSO participant shall be reported to the respective Region RC and his/her Safety Director. Any player who is bleeding must be immediately removed from the game and is not allowed to reenter the game until the bleeding has stopped and the wound is completely covered. Any part of the uniform that contains blood must be replaced before the player will be allowed to reenter the game. Substitutions for the bleeding player shall be handled in the same manner as any other injury.

22-SPORTSMANSHIP

Each upper division team will be evaluated and given points after each game by the referees and field coordinator for good sportsmanship and conduct by the players, coaches and spectators in the following categories:

- 1. Conduct of Players 0-5 Points
- 2. Conduct of Coaches 0-5 Points
- 3. Conduct of Spectators 0-5 Points
- 4. Uniform Appearance 0-5 Points
- 5. Courtesy Towards Referee 0-5 Points

(See the Sportsmanship Evaluation Criteria at the end of the rules for additional guidance in assigning sportsmanship points.)

An average score in each of these categories is 3. There will be a 2-point deduction in a category for a caution (yellow card) that is issued. If a team receives a send off or dismissal (red card) that team will receive ZERO TOTAL POINTS for that match. If a player receives two cautions or warning (yellow card) they will be sent off or dismissed (red card), the team will receive zero points in that category or categories. If a team was to receive three separate yellow cards during the match the team will receive ZERO TOTAL POINTS for that match. Points will be entered on the back of each game card by the referee. At the end of the season, the Area will award a sportsmanship party to the team or teams for each girls and boys division that receives the most sportsmanship points.

Sportsmanship points will also determine if a team will advance to Area Playoffs. The criteria are as follow; the average is 15 points per game, minimum is 1, maximum is 5 per category. The following is a scenario, the Area will add up the total number of games a team is scheduled to play in the regular season and multiple that total by 15. (say 14 games are played, that would equal 210 points). The total, 210 is then multiplied by 65%, (137 is 65% of 210 points in a 14 games season). A team that does not reach the minimum required points for sportsmanship will not advance to Area Playoffs.

23-SEASON

The season is defined by the period beginning August 1st and ending July 31st, and includes playoffs games, post-season games and tournament games.

24-NO SMOKING

NO SMOKING is allowed anywhere on the site. This includes E-Cigarettes/Vapes.

25-NO DOGS ALLOWED

NO DOGS are allowed anywhere on the site. Columbia is a public park where dogs are allowed, however, we do not want dogs near the field as the dog might get scared or excited and injure a player or referee. Please leave them at home or at least away from the field. Coaches are responsible for the spectators on the sidelines.

26-DISCIPLINARY ACTIONS

All participants (players, coaches and spectators) are subject to FIFA rules as modified by AYSO Rules, Regulations and Policies, Section One Rules and these Area F Rules regarding disciplinary actions as set forth below.

26.1 Should a player, coach or spectator be sent or dismissed from the field (verbally or by a red card) **BEFORE OR DURING A GAME**, they will be suspended from the remainder of that game and the next subsequent game actually played. Should a player, coach or spectator be sent or dismissed from the field for a second time during the regular league season, they will be suspended from the remainder of that game and two subsequent games actually played. Should a player, coach or spectator be sent or dismissed from the field for a third time during the regular league season, they will be suspended from the remainder of that game and three subsequent games actually played.

26.2 Should a player, coach or spectator be sent or dismissed from the field (verbally or by a red card) **FOLLOWING A GAME**, they will be suspended from the next two subsequent games actually played. Should a player, coach or spectator be sent or dismissed from the field following a game for a second time during the regular league season, they will be suspended from their next three subsequent games actually played. Should a player, coach or spectator be sent or dismissed from the field following a game for a third time during the regular league season, they will be suspended from their next four subsequent games actually played.

26.3 If a player, coach or spectator has a game suspension remaining at the end of the regular league season, that player, coach or spectator must sit out any actually played playoff games, post-season games and/or tournament games until the game suspension has been completed. If a player, coach or spectator has a game suspension remaining from a playoff game, post-season game and/or tournament game, that player, coach or spectator must sit out the next actually played playoff games, post-season games and/or tournament game(s) until the game suspension has been completed.

26.4 After a player, coach or spectator is sent or dismissed from the field (verbally or by red card), the referee MAY SUSPEND the game until that person has COMPLETELY left the area (out of sight and sound). The suspended player, coach or spectator is NOT ALLOWED to return to the field after the game is finished, nor is that person allowed to be present at the team's next played game or games, including regular league season games, playoff games, post-season games and/or tournament games, depending on the length of their suspension (don't come to the field - stay home!).

Suspended players not accompanied by a parent or guardian or who are unable to drive themselves away from the field will be sent to a "designated area" assigned by the AD. The designated area is for safety purposes, as these young people should not be sent out unsupervised. The suspended player is to remain in the designated area until the game is over and must not return to the field after the game.

26.5 Players, coaches and spectators who are suspended pursuant to the automatic penalties set forth in paragraphs 26.1, 26.2 or 26.10 are not permitted to attend any AYSO upper division game during the period of the suspension. Players, coaches and spectators who are suspended by the AD pursuant to the provisions of paragraphs 26.7, 26.8 or 26.9 below are not permitted to attend any AYSO game or other AYSO event during the term of such suspension. Should a suspended player, coach or spectator violate the "out of sight and sound" requirement during or after the game for which they were suspended, or during any part of the time they were suspended, a minimum of **one additional played game of "out of sight and sound" shall be added to the discipline requirement.** In addition, at the discretion of the referee or AD, should the player, coach or spectator continue to violate the "out of sight and sound" requirement, the game may be suspended and after a reasonable time, terminated.

26.6 AYSO and Area F disapprove of any form of abusive language which is intended or designed to embarrass, ridicule or demean others under any circumstances including on the bases of race, religion, gender or national origin. Players, coaches or spectators who resort to this behavior will be sent or dismissed from the field (verbally or by red card). This applies from the time the person arrives until the person leaves the playing campus, which includes the parking area.

26.7 In addition to the automatic penalties imposed in paragraphs 26.1, 26.2, 26.5 and 26.10, persons sent or dismissed from the field (verbally or a red card) for conduct contrary to AYSO philosophy occurring before, during or after a game may be suspended or expelled from further AYSO participation for an additional period of time pursuant to the provisions of this paragraph 26.7. In such circumstances, the game referees shall prepare an incident report and shall submit such report to the AD and to the RC of the region in which the person is registered.

The AD shall review the report and determine in his\her sole discretion whether sanctions in addition to those provided in paragraphs 26.1, 26.2 and\or 26.5 shall be imposed on such person. Prior to imposing such sanctions, the AD may, at his\her option, determine to convene a Due Process Review as described herein. In such cases where the AD determines to impose additional sanctions on the affected person without convening a Due Process Review, the affected person may also request that a Due Process Review is convened.

If a Due Process Review is convened, the Due Process Review shall be made up of three or more neutral area volunteers appointed by the AD. The date of the hearing will be set by the AD after considering the availability of the hearing board members, the game referee(s) and other witnesses. The Due Process Review will review all evidence related to the incident, although the referee(s) report and event information will be the primary evidence used by the Due Process Review. Based on its review of the information submitted, the Due Process Review shall recommend to the AD any additional discipline that they feel is appropriate as a result of the incident. The AD, however, has the sole discretion to make the final decision regarding any such additional disciplinary action. In all cases, persons subject to the provisions of this paragraph 26.7 shall be suspended from further AYSO participation until such time as the AD has rendered a final decision (with or without a Due Process Review) AND the person has satisfied all obligations imposed by the AD.

26.8 ANY PERSON WHO ASSAULTS OR THREATENS (EITHER DIRECTLY OR INDIRECTLY, PHYSICALLY OR VERBALLY) ANY OFFICIAL (REFEREE OR ADMINISTRATOR) WILL BE IMMEDIATELY EXPELLED FROM FURTHER AYSO PARTICIPATION FOR A MINIMUM OF THE REST OF THE SEASON AND MAY BE SUBJECT TO PERMANENT EXPULSION FROM FURTHER AYSO PARTICIPATION PURSUANT TO THE PROCEDURES SET FORTH IN PARAGRAPH 25.7 ABOVE.

26.9 ANY PERSON WHO ENGAGES IN OR ATTEMPTS TO ENGAGE IN VIOLENT CONDUCT WILL BE IMMEDIATELY EXPELLED FROM FURTHER AYSO PARTICIPATION FOR A MINIMUM OF THE REST OF THE SEASON AND MAY BE SUBJECT TO PERMANENT EXPULSION FROM FURTHER AYSO PARTICIPATION PURSUANT TO THE PROCEDURES SET FORTH IN PARAGRAPH 25.7 ABOVE.

26.10 Any participant accumulating a third caution or warning (yellow card) during the regular league season shall be suspended from participating in the next game actually played, including playoff games, post season games and tournament games. After the suspension is over, the participant will start clean with no caution, warning or yellow cards.

27-RULES/RULINGS

Rulings shall be the responsibility of the AD or their designee and shall be final. These rules do not supersede AYSO Rules and Regulations, but are intended to cover those situations not addressed by AYSO Rule and Regulations, which shall prevail in case of conflict.

28-POST SEASON TEAM FORMATION

In addition to these rules, Area 1F Select\Tournament Team Guidelines also apply to any post-season upper division team formed from an Area 1F region (or regions) to participate in AYSO secondary programs. The AD may request the RC to provide a copy of each AYSO tournament roster submitted by a team formed in their region for each

tournament that such team enters. In cases where a 14U player has requested to move up to the fall 16U program or a 16U player has requested to move up to the fall 19U program, that player cannot move back down to a 14U or 16U post-season team. In cases where a 14U player has participated in the fall 16U program or a 16U player has participated in the fall 19U program by request of their Region, those players may participate on either post season team, 16U; either 14U or 16U, 19U; either 16U or 19U post-season teams, but not both. Once a player has declared the division they will play in for the post season, they cannot be a guest player in the division they did not declare.
